


Dear Missionaries:

Webster defines the word "worthy" as: Having adequate merit; meriting; fit; as, worthy of promotion. In our missionary work we must be worthy to receive the many blessings to which we are entitled. Otherwise, our efforts may be in vain.

Being worthy is a matter of a lifetime. We grew up in the Church anticipating the day when we would be worthy to receive and accept a mission call. If we are converts, no doubt we were strongly influenced and converted by a person whom we considered worthy.

Now we are here in the mission and our call has become a reality. We have accepted the standards or goals of the mission which are consistent with the highest standards of the Church. It is obvious all through life and perhaps even more so here in the mission, that the righteous faithful person is, after all, successful, and, as a consequence, happy and satisfied. One cannot expect the blessings promised to the righteous if he is unrighteous. One may expect to be successful if he prepares for success.

This mission has reached new highs in success and it has been because, more and more, the missionaries who labor here have felt the impact of needing and working with the Spirit. And we have not yet reached the top limit. Nor will we in this life. But our reach upward must never cease.

Sister Hansen and I try and pray for help constantly to be worthy to direct the affairs of the mission. We rely on and need and expect your individual worthiness.

The Church is concerned with keeping accurate records and although I am sure that we are all aware of this fact, we sometimes allow ourselves to be careless in filling out baptismal recommendations. Please make sure that all information on the white, pink and yellow slips is accurate and complete. The following are suggestions to help our records be more accurate:

- 1. Fill out the papers before the baptismal service (preferably a day or two in advance) and not during the service because haste makes waste.
- 2. Double check spelling and all dates. (Have the person write his name on a slip of paper, check it, then copy it.)
- 3. The father's name must be complete and the mother's maiden name must be used. If the candidate's last name is the same as the mother's, check to see if the father recognized the child (went to "Registro Civil" to obtain a birth certificate.) If he did, the father's last name must be put on the recommendation. If not, please put (not recognized) after the candidate's name.
- 4. If the candidate is (or was) married, please include marriage date and complete names of all children with their respective birth dates and places.
- 5. If the candidate is not married but has children, include the complete name of the father(or the mother) and write NOT MARRIED, and list the children with their respective birth dates and places.
 - 6. When necessary, record the dates of deaths and divorces.
- 7. Please put branch number and name. For example: Guatemala #1, not just #1.
- 8. Take time to ask and be sure of everything because your record is the only one by which we know your baptism. YOU are responsible for ACCURATE RECORDS.

A new spirit of dedication and drive permeates the Mission. With emphasis on the need the fulfill the missionary calling in the best possible manner in the two short years given, the Guatemala-Bl Salvador elders established a new "Mission Challenge" last month. In the tri-monthly conference it was proposed that every elder should "set his sights" on the attainment of 70 effective hours and 30 lessons a week. Since then diversion day in many districts has ceased to exist until the district challenge is obtained. Then each district plans a well earned diversion day.

During the past month the new chapel in Los Jardines de Utatlan, zone 7 of Guatemala (branches #4-#10) City was inaugurated. The new San Salvador chapel will be well enough on its way towards completion that the May conference will be held there. Many missionary diversion day hours have been used in the completion of these buildings.

The past month has brought forth a flood of publications in local papers about the Church, its programs and members. It is necommended that these articles be used to advantage with investigators. Any ideas or suggestions for future publications should be addressed to the Servicio Informativo Guatemalteco-Salvadoreño at eht Mission Office.

In March, Elder Darryl Dunn, a new missionary of three months, achieved an admirable goal of 10 baptisms as a senior companion.

Pedidos of folletos or other materials from the Mission Office must be requested by all elders through their District Leaders. No individual request should be sent.

The Indian program is a unique and impressive part of our Mission. Divided into two language groups, Quiché and Cakchiquel, the program is organized into two districts under the leadership of Elders Paul Checketts and David Cunn. The Quiché district in Totonicapan is in the process of language learning and translation. Their big problem is the lack of any kind of grammar texts or aids. Presently they are begining an interesting program of Genealogy and Home Teaching with the Lamanites. The Atitlan district elders were very impressive with their testimonies and talks in the native toungue in a recent conference. They have also terminated their new text book, "Cakchiquel Para Misioneros". The Indian program elders are to be commended for their diligence and success in overcoming difficult language and living situations.

With twelve radio programs in Guatemala and El Salvador, every investigator should receive the invitation to listen to one of these interesting and inspiring Church programs.

USEAND CARE OF EQUIPMENT

The Guatemala-El Salvador Mission has approximately \$1,500 invested in taperecorders, projectors, films and tapes. This equipment has been made available in order that investigators may be aided visually in their fundamental knowledge about the Church.

It has been noted recently that a lack of care has been evident in the handling and use of these instruments, For example: Sony taperecorders have been seen beneath stacks of forgotten, dusty books and materials in Elders' bedrooms, stuffed beside beds while softly playing "The Sound of Music, " banged against sharp corners, and even falling out of buses.

Need it be said that even though this equipment seems easily available for any Elder, it is still expensive and important property of the Church!

A few basic guides:

Everywhere, except in Guatemala City, all equipment is the responsability of the District Leader. Individual district elders should immediately return it to him after use in a charla.

Taperecorders are not provided for individual usc. Even though seemingly convenient, tapes to send home to the folks are not to be made or played on Church equipment. To be eliminated also is the daily 12:30 P.M. relaxation music period. Musical soundtracks are for one's personal taperecorder, and should never be played on the mission charla equipment. Professional concerns rent taperecorders at approximately \$1.00 a day.

All of this equipment should be kept in a clean place where there is no dust, a clean closet for example.

Care should be taken that the machines are not scratched or marred by careless handling.

Watch out for buses!

As for broken equipment, burned out bulbs, old tapes or film strips, the District Leader should immediately advise by letter the Mission Literature Clerk so that no time will be lost in getting them repaired or replaced.

ATTENTION

On every elder's weekly report, there is a space allotted to note expenditures during the month. Each month we send a report to Salt Lake City and are required to indicate the average expenditures of the elders in our mission. Would you please write on the last report of each month the amount of money spent during the month. It would help us greatly in filling out our reports to The First Presidency.
